
Assessment p.1: Did the changes during the years 1500 to 1900 really cause people to 'redefine themselves'?

Your assessment task is to write a response to this **historical interpretation**, saying how far you agree with the historian's arguments.

TASK: First, read the interpretation, and answer the questions below to help you make sense of what the historian is arguing.



'Early modern Europeans had to **redefine themselves** in every way. Explorers proved the existence of vast new continents, previously unknown... Scientists would soon change people's view of the heavens, and of Earth's place in the universe, as well as the laws of motion and the understanding of the human body itself. Religious reformers destroyed the unity of the European Christian community. Virtually no important belief of the European world survived intact.'
